Message From Dean Horace Anderson



Last Friday, the first annual Elisabeth Haub School of Law Environmental Law & Policy Hack Competition ended with a team of students from Drake Law School winning a \$2,000 prize.

The innovative event was a big success, and the Drake students, Bradley Adams and Kathryn Leidahl, will be using those funds for implementing their proposal to tailor landscape ordinances to support Cedar Rapids, Iowa's stormwater management.

The Haub Law faculty chose three teams as finalists for the competition, an environmental law and policy problem-solving event that invited students from all over the country to propose an innovative and practical response to a current environmental challenge, and awarded seed funding to support implementation of the winning concept.

Two other teams were also selected as finalists by Haub Law faculty: a University of Colorado Law School team, which proposed producing climate-friendly landscapes in Denver that promote mitigation and adaptation to climate change, and a Vermont Law School team, which proposed developing "micro pocket wetlands" in Hartford, Vermont, to mitigate the impacts of climate change.

All three finalists were impressive in their knowledge of their communities and the ways environmental law, policy and politics intersect at the local level. These proposals would bring great benefits to their communities and would be useful models for climate change mitigation in New York and Westchester County as well.

The panel of final-round judges was also very impressive: Prof. Julie Cheslik of the University of Missouri – Kansas City School of Law; Prof. Shelby Green of Haub Law; Christopher Rizzo, a Haub Law alumnus and a Litigation, Environmental Law, and Land-Use lawyer with Carter Ledyard & Milburn LLP; and Daniel Zarrilli, Chief Climate Policy Advisor and OneNYC Director, NYC Office of the Mayor.

It's exciting to see potential real-world problems be so competently addressed by law students crafting real-world solutions. We wish the Drake students success with their plan in Cedar Rapids. I encourage all to watch a video recording of the event [here](#).
