#### **Message from Dean Horace Anderson**



Next Thursday, March 25, we will hold our annual Law Leadership Celebration, the signature fundraiser for Haub Law and a celebration to honor individuals or organizations that have made outstanding contributions to the legal community and the Law School. This year marks the 26<sup>th</sup> annual Law Leadership Celebration, and the first ever all-virtual event.

The Elisabeth Haub School of Law at Pace University is pleased to announce that **Shirley Lin will join its faculty in Fall 2021.** Currently, Professor Lin is an Acting Assistant Professor of Lawyering at New York University School of Law. She researches and teaches in the areas of civil rights, employment law, and contracts. Her most recent article, *Bargaining for Integration*, is forthcoming in the *N.Y.U. Law Review*. **Professor Karl Coplan** was featured in the article "Whiff of the unthinkable at EPA: CO2 standards for states" – read <u>here</u>. Professor Coplan was named to the inaugural Lawdragon 500 Leading U.S. Environmental & Energy Lawyers list for 2021, recognizing the leading U.S. lawyers shaping the future of the environment and energy. Professor Jason Czarnezki recently had his article cited: Jason J. Czarnezki, The Dubitante Opinion, 39 Akron L. Rev. 1 (2006). Cited In Concurrence: People v. Carter, No. 17CA2331, 2021 WL 922753 (Colo. App. Mar. 11, 2021). Professor Czarnezki's article "Sustainable Business Law? The Key Role of Corporate Governance and Finance" was accepted for publication in *Environmental Law* (forthcoming in December 2021). The article is co-authored with current Haub Law student Colin Myers.

Professor of Law Emeritus James Fishman is currently in the top 10% of Authors on SSRN by all-time downloads. SSRN is an e-library holding nearly one million research papers from nearly one half million researchers across 55 disciplines. Papers submitted to SSRN can be downloaded by other scholars, researchers and the public, making research easily available. Professor Fishman's 37 articles have been downloaded 53,097 times. He also was also in the top 10% of authors by the total new downloads in 2020. Professor Fishman's most recent article, "A Random Stroll Amongst Anthony Trollope's Lawyers" was among the top ten downloads in January 2021 in the following e-journals: Law & Humanities eJournal all papers; PRN: Legal Theories, Policies & Practice; Law & Society; and LSN: Law Firms/Legal Practice (Topic) All Papers, and Law & Literature eJournal All Papers. Professor Fishman notes that "Anthony Trollope (1815-1882) was the second most popular Victorian fiction writer after Charles Dickens. In his 47 novels over 100 lawyers appear, most of whom are characterized as shifty, dishonest, disagreeable, or fools. Toward the end of his career, after he met and befriended leading members of the Bar, his characterizations of some attorneys mellowed."

**Professor Bennett Gershman** published his article "Much Ado About One Dollar" in the New York Law Journal. Read it <a href="here">here</a>.
