#### **Message from Dean Horace Anderson**



After a difficult year, we are very pleased to relate that Haub Law will celebrate its 2021 graduation virtually on Sunday, May 16, at 1:00 pm. Haub Law's 43<sup>rd</sup> Annual Commencement speaker will be the Honorable Philip M. Halpern '80, U.S. District Judge, Southern District of New York. Virtual attendees will also hear from 2021 graduates Ross Keiser and Lauren Schnoebelen, as well as Pace University President Marvin Krislov. Pace University's Chairman of the Board of Trustees, Mark Besca, will confer degrees virtually.

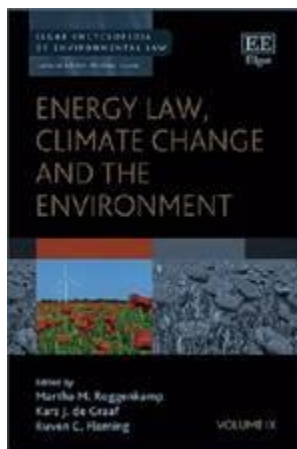
