The Advisory Committee is made up of 24 experts drawn from a wide array of fields including law, medicine, sociology, corrections, and public policy. The Correctional Association of New York is a 177 year old organization with the right to visit New York's prisons and report on the conditions of confinement. It is one of only two independent organizations in the United States with authority under state law to monitor prisons and report its findings to the legislature and the broader public.
