#### **Message from Dean Horace Anderson**



We are extremely pleased by the news that Haub Law Prof. Bridget J. Crawford has been named a Distinguished Professor, the University's highest faculty honor, by the Pace University Trustees.

This honor comes in recognition of a sustained record of extensive, extraordinary research and scholarship, outstanding teaching, and exemplary service to the University, community, and professional field.

I have known Prof. Crawford well for more than two decades, dating back to our days as first year section mates and study partners. "Distinguished" is a description that fits her well. We have taught together, served as Associate Deans together, and supported each other as scholars. She has brought boundless energy and enthusiasm to all of those endeavors.

Prof. Crawford's pathbreaking interdisciplinary scholarship explores how seemingly neutral legal rules and systems can reflect, exacerbate and sustain inequality. Her work draws on jurisprudence, statutory analysis, behavioral economics, critical tax theory and feminist legal theory to demonstrate how an equitable legal system can better serve human needs by taking gender, race and other identity factors into account.

In addition to being a renowned scholar, Prof. Crawford is also a beloved classroom teacher who inspires students and colleagues alike. I cannot begin to count the number of students who have said to me, "I thought I would hate Tax, but . . ." She is always willing to confer with, or partner with, colleagues on whatever courses they are teaching. In addition to Federal Income Taxation, Prof. Crawford teaches Estate and Gift Taxation; Wills, Trusts and

Estates; Tax Policy; Corporations & Partnerships; and Feminist Legal Theory. Her published work includes three casebooks, three books, and more than 100 scholarly articles and essays. Before joining the Haub Law faculty in 2003, she was a practicing attorney at Milbank LLP, where she specialized in taxation and estate planning. She is a graduate of Yale College (BA), the University of Pennsylvania School of Law (JD), and Griffith University (PhD) in Brisbane, Australia.

Please join me in congratulating Prof. Crawford, who joins Bennett Gershman and John Nolon as the Law School's Distinguished Professors.

### **Faculty, Staff, and School News**

**Professor Emeritus Jay Carlisle** and **Professor Nicholas Robinson** attended the Westchester County Bar Associations Virtual Swearing In Ceremony for the Association's 2021 - 2022 Officers and Directors. This event was in lieu of the annual banquet, cancelled because of the pandemic. Elisabeth Haub School of Law alumna, past WCBA President, and a Justice of the Supreme Court of the State of New York, Justice Linda Jamieson presided. She recognized the Association's close relationship with the Law School and praised Dean Horace Anderson. Justice Jamieson read the list of lawyers who were presented fifty year awards, which included Professors Jay Carlisle and Nick Robinson. Professor Robinson notes that, "by coincidence, we both joined the Pace Law School faculty in January of 1978, to help launch our law school when it was only 3 semester old...we were privileged to teach when Judge Jamieson was our student at Pace. Law is an inter-generational endeavor."

**Professor Smita Narula** supported the efforts of a group of human rights organizations and academics who have intervened in the first climate change case before the European Court of Human Rights to provide legal arguments to show that states have extraterritorial human rights obligations and must ensure special protection of children's rights.

**Professor John R. Nolon's** article, *Local Land Use Power: Managing Human Settlements to Mitigate Climate Change*, was published on May 1<sup>st</sup> in the Environmental Law Institute's Environmental Law Review. The article demonstrates that land use regulation can be retooled to greatly reduce or capture urban carbon emissions, and posits that mitigation efforts can lead to significant adaptation benefits, linking the two components of climate change management.

On May 2, 2021, **Professor Nicholas Robinson** led an Arbor Day Observance on the banks of the Hudson River in the Village of Sleepy Hollow. A sweet gum tree was dedicated in memory of those who died during the Covid-19 Pandemic. NYS Assemblyman Thomas J. Abinanti and Mayor Ken Wray participated along with poets and musicians, and civic leaders from the Philipse Manor Garden Club. Robinson emphasized the Village's tree ordinance, Chapter 385 of the Village Code and the NYS "Urban Forestry" Tree Cities programs. Additionally, Professor Robinson's book review is now in print, as of April 2021. It is the first comprehensive study of the environmental law of Singapore. Read it [here](#).

Congratulations to Gaby Dylag, who wrote the brief, and Todd Ommen and Karl Coplan for mentoring this amicus brief through the clinic.
