In an opinion rejecting defendant's motion to exclude an expert witness, the Federal District Court for the District of Oregon quoted **Professor Noa Ben-Asher's** recent article *Trauma-Centered Social Justice*, 95 Tul. L. Rev. 95 (2020). The Court relied on Professor Ben-Asher's article for the proposition that trauma based on the widespread impacts of racism in the United States is a well-established phenomenon.
