The Haub Law Emerging Scholar Award in Gender & Law is presented annually in recognition of excellent legal scholarship related to gender and the law published by a full-time law professor with five or fewer years of full-time teaching experience. After an open call for submissions, papers are reviewed on a blind basis by four members of the Haub Law faculty with expertise in this area. This
