Pace Energy and Climate Center presented to the monthly meeting of the environmental officers of the United Kingdom, European, Canadian and US embassies in Beijing of the China's stated plans to continue building coal-fuel power and chemicals facilities throughout the 2020s in an apparent ramp up to peak in 2030, and its increasing investments in natural gas supply and infrastructure towards its goal of full decarbonization by 2060. The presentation was requested by the United Kingdom's COP Unit in preparing like-minded countries for the UNFCCC COP-26 at Glasgow in November.
