Message from Dean Horace Anderson



I would like to invite the entire Haub Law community to attend an event in recognition of Distinguished Professor Bennett Gershman. Please join me on Wednesday, March 31, at 12:45 pm, to hear Professor Gershman speak on *Repairing the Damage: To Our Constitution, Our Democracy, Our Way of Life*.

The virtual event is hosted by Pace's Office of Research to honor our most recent Distinguished Professors, including Professor Gershman. The title of Distinguished Professor is the highest honor Pace University bestows upon a faculty member who has a sustained record of extensive, extraordinary contributions in research, teaching and service. It requires independent recommendations from nationally and internationally known scholars in the candidate's field.

We are extremely proud that Pace University has recognized Professor Gershman with its greatest faculty honor. He was instrumental in the founding of the Law School in 1976 and since then has selflessly provided us with the highest levels of teaching, scholarship, mentorship, leadership and friendship. Before coming to Pace, Professor Gershman was a prosecutor in the New York State Anti-Corruption Office, where he argued cases in state and federal courts involving public and political officials charged with corruption. He has written four books, over 75 articles in law journals, and hundreds of book reviews, essays, and op-ed pieces. His treatise, *Prosecutorial Misconduct*, initially published in 1985 and now in its second edition, has become a preeminent resource for scholars and practitioners seeking guidance on wrongful convictions.

As a leading authority in the country on prosecutorial misconduct, Professor Gershman is often called upon by the news media for his expertise. Attesting to his teaching effectiveness, Professor Gershman has received the Outstanding Professor of the Year award from graduating students eight times in the past 20 years. His sensitivity to the student experience is evidenced by his book, *The Law School Experience: Law, Legal Reasoning and Lawyering* (2000; co-authored with Lissa Griffin), which seeks to demystify the experience of being a law student.
