- IV. Dean for Students** Lori Kanner (for Angie D'Agostino)
- PLEAS fund has done well, raised \$56,000 to date since March, money has helped students with a wide range of needs including rent and medication
  - Thank you for supporting the students, especially recently with emails and gifts to the students in Dannat Hall!
- V. Admissions** Cathy Alexander
- Spring and Fall applications are trending up from last year with a 26% increase in total applications, in line with national applications
  - Spring class applications were up 29%, Fall applications up 16%-20% as well
  - A lot of changes due to virtual recruiting events, thank you to Michael Kremen for assisting
  - Still looking to improve the quality of the pool of applicants to the Flex program
  - The average LSAT of admitted students is 152, the average GPA of admitted students is 3.33, and we are always looking to raise those medians
  - The law school will not consider making the LSAT optional for admission consideration, although it does accept the GRE as a substitute for the LSAT for admission consideration
- VI. Dean Anderson's Update** Mark Meeker (for Dean Anderson)
- Thank you to the Board for its warm embrace and support of the virtual reunion
  - Thank you to the Board for the kind and caring support of students in Dannat Hall
  - The law school has pivoted very well during the successful Fall semester
  - The Spring semester calendar will, like the Fall, have little to no breaks for the safety and health of our community (school will end earlier due to the removal of winter and spring breaks)
- VII. Career Development** Mark Meeker (for Jill Backer)
- Jobs and internships for the class of 2020 are slow, but CD is continuing outreach
  - Any support the Alumni Board can lend to students looking for a job or internship would be greatly appreciated
- VIII. Alumni & Development Update** Lori Kanner / Arianne Andrusco
- Alumni Relations:
    - Monthly free CLEs for alumni (engaging 50-200 attendees each) have been incredibly successful; please reach out to Lori and/or Arianne if you would like to offer a CLE or assist with a panel/CLE on Diversity & Inclusion
    - Meet the Judges – Thank you to Mike Kremen, the event was a huge success
    - All Class Virtual Reunion (with activities that appealed to all— engaged 100s of alumni) – reached more alumni than in a regular reunion year
    - Looking ahead: Law Leadership Event – planned for the Spring
    - 1:1 match for PLEAS and the Pace Environmental Litigation clinic offered by the Sun Hill Foundation
    - Thank you for the gift cards for the Dannat Hall students—it was so incredibly thoughtful!
  - Development:
    - Giving Tuesday
    - Dean Anderson has identified the Annual Fund and Scholarship to be the law school's targeted needs
    - The PLEAS fund (Pace Law Emergency Assistance to Students) has helped over 25 students with emergency needs, however Dean D'Agostino still has outstanding

- applications because as soon as the money is raised it is distributed to students who applied and are in need at the law school
- The Bar Pass Initiative raised \$15,000 and was able to help 9 students this fall (efforts are ongoing and bar results are expected in December)
- Thrilled that 3x as many donors as last year

1. Nominating Committee Mike Frankel
  - Update and timeline for nominees for the 2021-22 school year – still accepting applications, has received applications from 8 individuals interested in joining next year's Board
  - By April 14, 2021 meeting we will have to present a slate, so we have time to consider additional candidates, please reach out to Mike if you have a suggestion or know anyone who might be interested
  - Mike will send an email to the committee; a proposed slate by early January 2021 is ideal
  - We can have up to 45 Board Members, so there is room for more
2. Social Committee Jeremy Farrington
  - P.L.A.N. event #38
    - Scheduled for Nov. 18, Zoom around 6:15, Matt Donovan will perform again
3. Judicial Committee Mike Kremen
  - "Meet the Judges" virtual event
    - Held 10/19 & 10/20 in sessions 12:30 - 1:30 p.m. & 5:30 - 6:30 p.m. each day
    - Great success with over 150 people attending, and a few students received internships from interacting directly with judges at the event
    - Some technical hiccups on the first day, but moved to Zoom and people got to see each other and interact with judges, and all went (generally) well
    - Several Judicial Committee members moderated a variety of rooms
    - Perhaps next year we will be better able to tout our involvement
  - "What Judges Expect" – a planned Spring event
    - Aiming for a date in mid-to-late March, likely March 23, 2021
    - This will be a bit different than Meet the Judges in that judges will be educating attendees on what they expect from practitioners who appear before them
    - Hoping to provide CLE credit, record, and raise money for the school
    - Hoping to find sponsors and monitors
