Darryl Austin

For almost two decades, Darryl Austin has represented developers, lenders, investors and governmental agencies engaged in economic development and community revitalization initiatives. Darryl's particular expertise is the complex tax and organizational structuring of partnership syndicates utilized to facilitate historic and affordable housing tax credits.

Darryl has closed hundreds of projects which were financed with IRC Section 42 affordable housing and Section 47 historic tax credits and which were supported by:

HUD programs including RAD, Section 221(d) (new construction), Section 223 (refinancing), Section 232 (healthcare), Section 202/811 (seniors/ disabled), and Section 8 operating subsidy; tax-exempt bond financing enhanced by Fannie and Freddie; funds provided by Federal Home Loan Bank members; and state and local funds.

Prior to joining Goldstein Hall, Darryl was an attorney at a large Washington, DC law firm, HUD, the New York State Housing Finance Agency and a large national developer.

Marianne DiTommaso

Vice President, Saint Joseph's Medical Center, St. Vincent's Hospital Westchester Division



Ms. DiTommaso has, for more than 35 years, led the development and operations of residential/supportive housing opportunities for individuals living with serious mental illness, substance use disorders, HIV/AIDS, formerly homeless and other special needs populations.

Since 1986 Ms. DiTommaso has developed and oversees more than 1,300 housing units across Westchester County and four boroughs of New York City. Under her leadership, a full continuum of housing, from transitional licensed community residences through permanent supportive housing, provides seamless support to individuals so they may

achieve their recovery-oriented goals and live independently in the community.

Additionally, other programs which she developed and oversees include an affirmative business which provides employment for adults with serious mental illness, a Care Coordination program, an Assertive Community Treatment Team, a Personalized Recovery Oriented Services (PROS) program as well as three Opioid Treatment Centers – which provide medication-assisted treatment to over 2,300 patients.

Ms. DiTommaso holds Master's degrees in Social Work (MSW) and in Business Administration (MBA) and is a NYS Licensed Clinical Social Worker.

Ms. DiTommaso's professional publications and presentations have included; "An Integrated Clinical and Administrative Database for Mental Health Care Providers and Consumers", presented at the 5th Congress World Association for Psychosocial Rehabilitation, Rotterdam, The Netherlands; "SQL Clinic: The Open-Source Alternative for Electronic Medical Records" Thomas Good and Marianne DiTommaso. Psychiatric Services (Journal of the American Psychiatric Association), March 2005 and "Rainbow Recycling: A Model Business for Individuals Recovering from Mental Illness", presented at the NYS Rehabilitation Association, Albany, New York.

A strong advocate for the housing needs of individuals with mental illness and other special needs, she serves on the Board of Directors of the Association for Community Living a statewide association of providers of mental health residential and housing programs, as well as several other local and state mental health committees and housing campaigns.

Ms. DiTommaso has been honored by the National Alliance for Mental Illness–NYC–Staten Island for her advocacy on behalf of persons with mental illness and their families (2004). She has also been honored by the Sisters of Charity with their "Mission Award" (2009) and their "Fire of Charity" award (2019) In 2018 Ms. DiTommaso was the recipient of City & State New York's "Above and Beyond Award" as one of New York's "30 Most Remarkable Women".

Christopher Illum is the Executive Director of the Habitat for Humanity New York City Community Fund, as well as the VP of Housing Services for Habitat for Humanity New York City. Chris received his bachelor's degree in sociology from Temple University in 2005 and master's degree from Hunter College Department of Urban Planning and Policy in the winter of 2010. Since 2007, Chris has been working in different roles developing and preserving low- to moderate-income housing here in New York City.

Senior Vice President and Chief Strategy Officer for Portfolio Preservation, NYS Homes and Community Renewal



Prior to joining HCR Becky gained extensive experience in the housing and community development field at the local, state and national levels. Most recently Becky was Director of Neighborhoods and Housing at the Boston Foundation overseeing TBF's grantmaking related to housing and community development as well as program-related investments. She also rand the Moelis Institute for Affordable Housing Policy at New York University's Furman Center for Real Estate and Urban Policy where she led all aspects of the Institute's operations and policy work, as well as worked with New York's affordable housing community on key issues facing the city and the housing

sector. Previous to that, Becky was Advisor to the Secretary at the U.S. Department of Housing and Urban Development in DC, where she coordinated and led HUD and the Administration's housing and economic development priorities. to create approximately 700,000 kW/h of clean energy per year and lower operating costs.

Jason has been integral in developing the Firm's Faith-Based Practice Group, which works with faith-based organizations to protect assets, evaluate options, and maximize real property. He is a frequent panelist and guest speaker on faith-based and nonprofit issues, presenting at, among other venues, the Manhattan Borough President's Religious Facilities Task Force and leading the Firm's collaboration with the New York State Council of Churches' (NYSCC) Who is My Neighbor seminars. Her work includes developing public engagement strategies and conducting feasibility analyses on town center developments. She conducts assessments and audits for municipalities in sustainable development, resiliency, State certification programs, and streamlining development processes. Ms. Zezula also provides strategic assistance to local governments, including assistance in developing collaborative public engagement approaches on land use project disputes and comprehensive planning. She has created various public engagement reports for communities across NY and CT.
