I. Welcome and Introductory Remarks

- Introduced Samantha Gordon and her role with the Board
- Samantha is based in NYC and would welcome reach-outs

I. Dean's Update

Jill Gross

- Recent NY bar passage results for July 2022 were 61% for first-time takers, a disappointing and unacceptable result (15 point drop from 2021 and 6 point drop from 2020)
- A working group has been convened to understand what went wrong and to assist students so that they pass in February 2023

- Although a new academic success staff member was hired to support bar passage, that position just started in August 2022
- Gathering data to determine correlations between the pass rate and other factors
- Good reasons to think this was an anomaly because the class (January 2020 admission class) was the most impacted by the pandemic of all classes
- Engaging in early interventions for Class of 2023 moving forward
- We do not know comps from other schools, but have heard anecdotally that most went down a little and a few went down a lot
- Covid affected us more than other schools because students were closer to the cut score LSAT mean was 151, a little below other classes definitely a correlation between LSAT and pass rate (GPA after first year is the best predictor) students below 150 on LSAT generally have a lower pass rate
- Received reports today from BARBRI and Kaplan, gathering information from them about student participation and engagement, etc.
- Working full-time while studying for the Bar is a high predictor of not passing
- Pace offers 2 free Bar courses to all students; 160 students registered for MBE Strategies next Spring
- School will re-examine its movement toward more open book exams since the New York Bar still requires memorization
- NextGen Bar: new iteration, out in 2026, will be less memorization and more emphasis on skills unclear whether New York will adhere
- There should be follow-up communications regarding findings, alumni involvement through mentoring etc. is always welcome gold standard is above 75% pass rate for all Bars cumulatively, which should still be met notwithstanding the poor performance on the New York Bar

II. Admissions

- Brian noted that he was deputized by Cathy Alexander and provided a Powerpoint
- Admissions office back on the road for more in-person recruitment
- Participated in 7 law school admission forums throughout the country as well as numerous events at colleges and universities
- Continuing on-campus tours and events for prospective students
- Admissions office is 20% into the admissions cycle; so far, application numbers are lower than in 2021 and 2022, down 13% as of November 11
- We are now in unsettling economic times that could impact admissions
- Will be increasing social media outreach
- CCPD Center for Career & Professional Development reports that of the Class of 2022, over 82% of graduates are employed (almost 79% in full-time legal jobs)

- Reunion this year required a pivot because there was low interest in the event
- Discussion ensued regarding how best to conduct reunions in the future, including time of year, time of week, type of event, etc.; commentary that off-site in NYC could be special
- Registration for the reunion was closed too early, walk-in registration could be helpful
- Samantha will follow-up and try to utilize the Board moving forward
