III. Admissions Cathy Alexander

- 24 students enrolled in January class, a nice mix of great students
- Now focusing on Fall applications, down in volume which mirrors nationally, but up from 2-3 years ago
- Nice draw to part-time Flex program
- Focus is now on engagement of admitted students, so that they choose Pace
- April 15 is the deadline for students to choose, will ask Alumni to get engaged

IV. Advanced Health Law and Policy Certificate

Brian Kearney

- Jessica Bacher, Executive Director of Land Use Law Center, provided information for re-launch of Advanced Health Law & Policy Certificate for JD students, which is a growth opportunity
- 17 JD students have applied for the Certificate, there is a strong demand
- Health law classes are full
- Online Health Law and Policy Certificate has received approval from the State and ABA, launched in connection with Pace University Online
- Pandemic health and social issues have brought this to the forefront
- Burgeoning partnerships, including with White Plains Hospital
- Advisory Group formed to explore Health Law & Policy Institute
- Exploring coordination with undergraduate programs, such as Pace College of Health Professions
- Lisa asked what credits were required for the Certificate for JDs, and Brian responded he will find out

V. Sustainable Business Law Hub

Brian Kearney

- ESG (Environmental, Social, Governance) has become very important for corporations and law firms training attorneys to move into this space is a real growth opportunity
- Kickoff was held on September 21, 2022, and was well-attended by business, environmental and legal professionals (a conference was held last Summer as well) great networking event
- Will serve as an incubator space, with a think tank
- Interested in establishing externships and internships
- Barbara Ballan has been named the inaugural LLM Sustainable Business Law Fellow of the Hub
- Hub would like to place students with ESG areas at banks, corporations, firms

VI. Development Update

Samantha Gordon

- Setter Connect Platform Alumni mentoring platform (alumni to student as well as alumni to alumni)
 - Has been in existence for 6 years, but more focused on undergrads relaunch expands it to the Law School
 - o Alumni aren't really finding opportunities to connect by attending events

- o Think about this as LinkedIn, but specifically for Pace
- o Enhances leadership and communication skills, will motivate and give back to other students and alumni
- Can connect with people based on your interest can join via LinkedIn, answer questions that will assist with connecting can also join at 222.pace.edu/mentoring also visit Setter Connect page on the website
- o Students can seek out alumni, but alumni cannot see students unless they seek us out
- o Hoping that mentorships can be long-term
- o Personal information is not shared, and in-person meeting is not encouraged until the relationship is well-established better to get to know one another through the platform
- Alumni-to-Alumni you can search within all the alumni, see where they work, message
 and create connections, and can create groups based on shared interests
- o Job board you can post positions that are available, and search alumni that have worked at the company even in different roles
- Will be putting podcasts on, and will be robust and continue to build
- With last graduating class, 161,000 living alumni
- Lisa asked if this is in addition to the law school's in-person mentoring program, and she asked if that program is still in existence – Brian said that he would look into that
