- To Amend Proposed IUCN Programme 2017-2020 to Phase Out Fossil Fuel Dependence and Subsidies
In order to fulfill the Paris Climate Change Agreement pledges for greenhouse gas reductions and to meet the resulting economic gains specified in the UN-adopted Sustainable Development Goals #12C, 7 and 13.
Co-Sponsors: Governments of Fiji & Tonga; Sierra Club; ICEL; Environmental Law Program, William S. Richardson School of Law, University of Hawaii; Ecological Society of the Philippines; and NRDC.
- To Appeal Denial of ALDF's Application for Membership to the IUCN
Which should be granted due to ALDF's longstanding commitment to conservation and environmental responsibility. This was more than sufficient for the US Fish and Wildlife Service and the CITES Secretariat to approve ALDF for attendance at several CITES Conferences of the Parties – including COP 17 in Johannesburg this month, and likewise should be more than sufficient for membership approval with the IUCN.




