### Basic Requirements:

1. All candidates must complete at least 16 environmental course credits with an average GPA of 3.00 (B) or better and no grade below a C in those courses. These credits must include Environmental Law Skills & Practice, Survey of Environmental Law, and Administrative Law. In addition to these required courses, candidates must take one of the following: Agriculture and the Environment, Climate Change, Energy Law, Env Justice, International Env Law, Food Systems Law, Land Use Law, Natural Resources Law or Water Rights and Resources. Candidate must also complete at least one environmental experiential learning opportunity and one significant research paper on an environmental law topic broadly defined. Certificate candidates must also maintain an overall grade point average (GPA) of 2.8 or better. The remaining required course credits may be selected from the numerous environmental law electives and for-credit experiential learning opportunities listed on page three of this packet.

2. **Writing Requirement:** Candidate must complete one significant research paper on an environmental topic, broadly defined. The written product must be in the form of a research paper, scholarly article, legal memorandum, or law review note. The written product must be at least 15 double-spaced pages, demonstrate an appropriate level of legal research and analysis, be well-organized and well-written, and contain ample citation to legal authority. Other products may be accepted with prior approval by the Administration of the Environmental Law Program. A student may use their ULWR to satisfy this requirement if it is written on an environmental topic. **Please be sure to submit the Env Certificate writing requirement form with this application.**
